New Business

Trails Condition

- MJMF trails are now closed completely for the logging and habitat restoration project. No projection on when they will open again. When they are ready, we will need to access and clean up any slash left.
- LRP Ridge Trail; the log across the trail was cleared by Martin Thornton and Chris Regan.
- There is a tree down in the TF near the Transfer Station Parking lot on the left side yellow trail.
- A cost summary of the Puncheons for the TF was submitted by Martin Thornton and added to the Bridge summary worksheet. This is based on a survey Chris Regan, Dennis Regan, and Martin Thornton completed in November.

Writing

- The QR code trail highlights have been completed. See the notes under the CC Report.
- The Structure Approval Guide was completed by Martin Thornton and sent out for review. Deb Sugerman will forward to the CC for comments. He is working on the Design and Maintenance Guide.
