**SCOPE OF WORK**

It is the intent of this proposal to establish a primary source of supply for #2 Heating Oil and Off Road ULS Diesel for Fiscal Year 2019 (Date of award through June 30, 2019) and Propane for either the Fiscal Year 2019 or, alternatively, three Fiscal Years 2019-2021. This bid is being issued as a collaborative effort by the Town of Lee, The Oyster River Cooperative School District (ORCSD) and the Lee Church Congregational, hereafter collectively referred to as the “Owner.” **Please note, however, that the Town of Lee reserves the right to accept a proposal for propane separate from the Lee Church Congregational and/or the ORCSD; therefore, please indicate on your proposal form if there will be a cost difference.**

The annual consumption for each type of fuel is an estimate only and the Owner reserves the right to purchase only the quantities necessary, whether more or less than the estimated amount needed with no impact to the bid price. See attached listings for tank sites and capacities. Tank sites and/or capacities may be changed during the course of the contract year. The brand and quality of the products being offered shall conform to industry standards. Deliveries shall be made to the individual tank locations and it shall be the responsibility of the successful Bidder to verify each fill location and to maintain sufficient quantities at each location to assure proper operation. Failure to do so may result in the assessment of damages.

Each invoice must reference the fill location and include the fill ticket.

Each fuel type will be awarded separately; bidders are not required to submit bids for each type of fuel.

Bids are being solicited on Price per gallon markup.

The markup amount shall be firm for the contract period, which will be from the award date through **June 30, 2019 (2021)**. **All bid prices shall include any and all surcharges and fees. The Owner is exempt from any and all Federal Excise Taxes and the NH Road Toll.** All bid prices shall be FOB delivery location.

**#2 Heating Fuel and Diesel are to be priced based on the Sprague rack previous days’ closing price in Newington, NH. Propane is to be priced based on the most recent listing of the Mont Belvieu, TX price per gallon in the Wall Street Journal prior to each delivery.**

The Town of Lee and ORCSD terms will be net 30. Lee Church Congregational terms are net 15 days.

Through the term of the contract, the successful bidder shall be subject to the insurance requirements and indemnity provision as shown in Attachment A hereto.

The successful Bidder shall, upon Notice of Award, furnish a Certificate of Insurance showing general liability, automotive, and worker’s compensation in the amounts required by this Bid.

The Owner reserves the right to request background information on the bidder such as place of incorporation, principal and local offices and years in operation. In addition the Owner reserves the right to request references from any and/or all bidders for evaluation. By submitting a bid, Bidder warrants and promises that it will comply with all state and federal requirements for the transportation, storage and handling of the fuels to be provided under this bid.

Addenda to this bid document, if any, including written answers to questions, will be posted on the Town of Lee website at [leenh.org](http://leenh.org) under the “Bids & RFP’s” section. Addenda and updates will NOT be sent directly to firms. Vendors submitting a bid should check the web site daily for addenda and updates after the release date. **ATTACHMENT A**  
**INSURANCE & INDEMNIFICATION REQUIREMENTS**

**Insurance must cover the accidental discharge of fuel during the course of performance of this contract.**

The Vendor agrees that it will carry any and all insurance which will protect it, the Owner and their officials, agents, volunteers and employees from any and all claims and demands, costs, damages, loss of service or consortium, expenses, compensation and attorneys' fees including but not limited to any and all claims for personal injury and/or death, workers' compensation injuries, and property damages which may, in any way, arise from or out of the operations of the Vendor whether such operations be performed by the Vendor itself, anyone directly or indirectly employed by it or any other persons or company retained in any way to carry on all or portion of the operations, activities or work required by or related to the Contract. The Vendor further agrees that the Owner and its officials, agents, volunteers and employees shall be named as an additional insured in any and all such liability insurance policies required by the Owner.

Prior to commencing work, the Vendor shall demonstrate that it carries a general liability policy with limits of \$1,000,000 per occurrence and \$2,000,000 aggregate, as well as completed operations coverage, applicable to the work performed under this Contract and all liabilities as set forth above. The general liability policy must also contain contractual liability coverage applicable to the contractual indemnification obligation set forth below.

The Vendor shall provide proof of automobile insurance coverage in an amount deemed satisfactory to the Owner.

The Vendor will furnish to the Owner a Certificate of Insurance and an endorsement prior to executing the Contract or commencing work demonstrating that the Owner and its officials, agents, volunteers and employees are named as an additional insured on the general liability and automobile liability insurance coverage.

The Vendor shall provide proof of workers compensation insurance meeting State of New Hampshire required limits. The Vendor's worker's compensation coverage must waive subrogation against the Owner and its officials, agents, volunteers and employees.

**ADDITIONAL INSURED**

All liability policies (including any excess policies used to meet coverage requirements) shall include the Town of Lee, New Hampshire, Oyster River Cooperative School District and Lee Congregational Church as named Additional Insureds.

**INSURANCE & INDEMNIFICATION REQUIREMENTS**

To the fullest extent permitted by law, Vendor shall protect, indemnify, save, defend and hold harmless the Owner, including its officials, agents, volunteers and employees (“Indemnified Parties”), from and against any and all liabilities, obligations, claims, damages, penalties, causes of action, costs, interest and expenses, including but not limited to reasonable attorney and paralegal fees, which Indemnified Parties may become obligated or suffer by reason of any accident, bodily injury, personal injury, death of person, or loss of or damage to property, arising indirectly or directly under, out of, in connection with, or as a result of this Contract or the activities of Vendor or its agents, employees, Vendors or sub-vendors, and even if caused in whole or in part by any negligent or intentional act or omission of Indemnified Parties.

In addition, and regardless of respective fault, Vendor shall defend, indemnify and hold harmless the Indemnified Parties for any costs, expenses and liabilities arising out of a claim, charge or determination that Vendor’s officers, employees, Vendors, sub-vendors or agents are employees of the Indemnified Parties, including but not limited to claims or charges for benefits, wages, fees, penalties, withholdings, damages or taxes brought in connection with laws governing workers compensation, unemployment compensation, social security, Medicare, state or federal taxation, and/or any other similar obligation associated with an employment relationship.

The Vendor’s obligations to defend, indemnify and hold harmless the Indemnified Parties hereunder shall survive the term of this Contract.

The Owner shall not be required to defend or indemnify the Vendor, any sub-vendor or any professional service provider.
