# TOWN ELECTIONS, MARCH 9<sup>th</sup>, 7am – 7pm at the Transfer Station Voters will stay in their vehicles at all times and must wear a mask

Due to concern for the safety of voters and poll workers, the Town has opted to conduct "drive-through" voting as a temporary measure as authorized in 2020 by NH HB 1129. The Transfer Station offers the space and traffic flow to facilitate this event. This is a unique approach to voting for our town but not unique in the state. Your cooperation and preparation will help us make this event a success. Please note: the Transfer Station will be closed for normal waste disposal on this day.

#### 3. When to arrive

The following are some <u>suggestions</u> to even out the flow of voters arriving at the Transfer Station:

- a. **Lessons learned from the November Election**; nearly half the voters in town showed up between 7:00 and 9:00am, creating the only long lines of the day.
- b. 7:00 to 8:00 am should be a priority for those needing to get to work.

#### 4. Who should be in the vehicle

- a. Arrive alone for maximum privacy of your vote, otherwise, any number in the car can be accommodated
- b. It would be helpful for the poll workers to have people of the same last name in the car but mixed loads can be accommodated

#### 5. Absentee Ballots

Absentee ballots should be delivered to the Town Clerk (249 Calef highway) prior to Election Day but may also be dropped off at the polls on Election Day before 5:00pm.

#### 6. Voter registration

New voters who are legally qualified and carry the appropriate documentation can register to vote at the Transfer Station facility the day of the election. Please inform the greeter that you are not currently registered to vote and you will be directed to the registration area.

#### 7. Postponement

If the National Weather Service issues a warning indicating hazardous conditions or a disastrous accident occurs, the voting would be postponed for two weeks, until March 23<sup>rd</sup>. Notice of this postponement would be issued before 6:00pm on March 8th, and declared on the town website, Facebook, WTSN radio and WMUR TV.

#### LEE TOWN OFFICES HAVE RELOCATED

The Selectmen's Office/Assessing, Town Clerk/Tax Collector, and Planning & Zoning/Building Department are now located at 249 Calef Highway (aka Route 125.) The building is open to the public; however, all covid-safe practices, such as mask wearing, hand sanitizing and social distancing are in place. #### EMERALD ASH BORER FIELD WORKSHOP

Emerald ash borer (EAB) is an extremely destructive invasive insect that attacks ash trees. It was first found in New Hampshire in 2013 and is now well established in the southeastern part of the state. Join Strafford County Forester Rebecca DiGirolomo, UNH Forestry Professor Emeritus Don Quigley, NH Division of Forests and Lands, Forest Health Specialist, Bill Davidson, and Lee Conservation Commission member, Anne Tappan for an educational workshop focused on learning ash tree identification and signs of EAB damage. We will start out as a group for an update on the status of EAB in NH. We will then break off into smaller groups with our four instructors and hike a short distance into the town forest to identify and survey ash trees for EAB.

**Special COVID-19 Safety Precautions:** Program will be limited to 20 participants, with social-distancing and masks required. The entire program will be held outdoors. Participants will be required to complete a simple online health screening before leaving home. Additional information will be sent upon registration.

What to bring: Face mask, warm clothing, water, snacks, and sturdy footwear. Binoculars and a hand lens are recommended but are not required. Due to COVID-19 protocols there will be no sharing of equipment, food or drink between participants.

**Additional details:** Please dress appropriately as we will be outdoors and walking on and off trail in the woods.

#### \*MIXED PAPER\*

Mixed paper should still be placed with Municipal Solid Waste (MSW) EXCEPT please separate your office paper and magazines from your mixed paper in order to start the Town's recycling revenue back up again. Acceptable paper items are copy paper, envelopes (windows ok), junk mail (no glossy mail), any magazines.

#### PLEASE CONTINUE PRACTICING SOCIAL DISTANCING

Both bays remain open as we have seen an improvement in the flow of traffic, but everyone has to maintain the recommended safe distance of 6' while inside. In order for our employees and residents to maintain a safe distance, employees will not be stationed on the wall during this time but will be available to answer questions.

#### PLEASE KEEP CHILDREN IN YOUR VEHICLE

<u>PLEASE</u> have your child(ren) stay in your vehicle while you are disposing of trash and recyclables. This is for their safety! If they have to be out of the vehicle please keep them next to you at all times and do not let them run through the Transfer Station, roadways or parking areas.



The department remains fully staffed and operating during the Covid-19 pandemic to protect our community but must continue to modify the way we provide some of its services. The Safety Complex remains closed to all visitors for the foreseeable future, but business will continue to be conducted via phone or email. Go to https://www.leenh.org/fire-department.

Burn permits are still required for all outside burning and all State burning regulations are still in effect. Burning regulations and permits can be found **HERE**. Please check to see what the fire class for the day is prior to lighting any outside fire. Class 3 day or higher, all outside burning is not allowed. You can find out what fire class day it is by visiting the NH Forest and Lands website or look at the road side board at the Public Safety Complex.

All station tours remain suspended as are all home visits for wood stove, burn permit and inspection purposes. Furnace installation inspections will be conducted on an emergency basis for emergency replacement only. All furnace replacement work shall be coordinated through the Fire Chief's office before any work is to be done. All Covid 19 related inquiries should be made to the Town's Health Officer, Caren Rossi 659-6783 or <a href="mailto:crossi@leenh.org">crossi@leenh.org</a>.

Winter is here and we would like to pass on some friendly reminders for fire safety:

- Change batteries in your smoke and carbon monoxide detectors
- Have furnaces and water heaters (fuel burning) cleaned and inspected annually.
- Have woodstove and fireplace chimneys inspected and cleaned annually. Only burn seasoned hardwood to reduce creosote build-up. Burn your woodstoves at high temperatures occasionally to burn off creosote build-up in the chimney.
- During power outages practice generator safety and keep generators at least 10' from the house in a well-ventilated area. Never run them inside the house or a garage.
- Keep all vents on your home free and clear of snow and ice.
- Keep all means of egress from your home shoveled and clear for easy escape in case of fire.
- Ice should be at least 4" thick to be considered safe to walk on. Stay away from areas where there is running water or current as they will not freeze enough to hold a person's weight.

We hope you all have a safe and happy winter season. Remember to please wear a mask in public, practice social distancing and wash your hands frequently to help prevent the spread of Covid 19.

#### FORBEARANCE & FORECLOSURE PROTECTIONS for HOMEOWNERS

Last week, the Biden-Harris Administration announced an extension of COVID-19 forbearance and foreclosure protections for homeowners. The actions announced this week will extend the foreclosure moratorium for homeowners through June 30, 2021; extend the mortgage payment forbearance enrollment window until June 30, 2021 for borrowers who wish to request forbearance; and provide up to six months of additional mortgage payment forbearance, in three-month increments, for borrowers who entered forbearance on or before June 30, 2020. #### MEDICAID HOME AND COMMUNITY BASED SERVICES

Last week, Senator Shaheen joined in sending the attached letter to Senate leadership in support of the inclusion of dedicated emergency funding for Medicaid Home and Community Based Services (HCBS) in future COVID-19 relief legislation. The Senators called for the increases to the Federal Medical Assistance Percentages (FMAP) included in the House proposed COVID-19 relief legislation to remain in the final package. The Senators shared that this "targeted relief funding is essential for older Americans and people with disabilities who live and receive services in their homes, and the workforce that supports them, as well as for state Medicaid programs." The letter is attached here for your reference.

#### PAYCHECK PROTECTION PROGRAM

The SBA announced upcoming changes to the Paycheck Protection Program (PPP). Beginning Wednesday (2/24), there will be a 14-day exclusive PPP loan application period for businesses and nonprofits with fewer than 20 employees. The remaining changes outlined in today's announcement are expected to be rolled out the first week of March. Borrowers must apply for a forgivable PPP loan before the March 31<sup>st</sup> statutory deadline, subject to the availability of funding.

#### **NH DHHS Announces Online Purchasing Program for SNAP Recipients**

**Concord, NH** – The New Hampshire Department of Health and Human Services (DHHS), Division for Economic and Housing Stability (DEHS) has received approval from the U.S. Department of Agriculture (USDA) to participate in a pilot program that allows recipients of Supplemental Nutrition Assistance Program (SNAP) benefits to purchase and pay for groceries online. The <u>SNAP Online Purchasing Pilot</u> program allows the use of Electronic Benefits Transfer (EBT) cards to purchase eligible food items through two authorized online retailers, Amazon and Walmart.

"Online purchasing is one more way New Hampshire residents can access good nutrition throughout the duration of the COVID-19 pandemic," said DHHS Commissioner Lori Shibinette. "Purchasing groceries online is safe, secure, and helps people maintain social distancing measures that help slow the spread of COVID-19 in our communities."

The SNAP Online Purchasing Pilot was established by the federal 2014 Farm Bill, which mandated a pilot to test the feasibility of allowing online transactions using SNAP benefits. In 2017, eight states were selected to be part of the pilot, which was launched in New York State in 2019, followed by Washington in January 2020. Additional states have joined the program as a result of the COVID-19 pandemic. # NH Department of Health and Human Services Resource Guide and Warm Line to Support Families during COVID-19

**Concord, NH** – The New Hampshire Department of Health and Human Services (DHHS), Division for Children, Youth and Families (DCYF) has developed two new resources to help children, youth, families and caregivers during the COVID-19 emergency.

The first is "Supporting Child and Family Wellbeing During the COVID-19 Emergency," a new resource guide with practical tips on how we can all support children and families during COVID-19. The guide also provides a list of resources available to families statewide. The second resource is the Family Support Warm Line, a partnership between DHHS and Waypoint. The Family Support Warm Line is a no-cost, confidential phone support line focused on promoting family resiliency. Residents can call 800-640-6486 and speak with family support professionals and parent partners for help with managing family challenges, coping strategies, or emotional support during COVID-19. "Our data has shown a decline in the number of calls made to DCYF from those community helpers who regularly see kids face to face, but this is continues to be a stressful time for families and our focus has to remain on prevention," said DCYF Director Joseph Ribsam. "Having resources readily available and a place where parents and caregivers can turn if they need to talk to someone can make a difference for our families and guide them to the services they need to stay strong and healthy, before they reach a tipping point that leads to abuse or neglect."

The efforts stem from Emergency Order #22, issued by Governor Chris Sununu on April 1, which authorizes emergency funding for critical child protection services to ensure that New Hampshire families continue to receive the right services at the right time during the COVID-19 emergency. In addition to the Family Support Warm Line, the funding will support domestic violence and substance use supports, expansion of the DCYF Strength to Succeed Program, and additional technology support for DCYF-involved families.

March data from the Division for Children, Youth and Families (DCYF) shows a <u>decrease in referrals</u> to DCYF's Central Intake, compared to the same time period over the past two years. New child abuse and neglect referrals are down nearly 50% each week overall. 



### OYSTER RIVER COOPERATIVE SCHOOL DISTRICT SCHOOL BOARD NEWS February 17, 2021

Voting for 4 school board seats, the school budget for 2021-2022, and other school items will be March 9, 2021 along with town elections in Durham, Lee, and Madbury. All voters in Oyster River towns vote for all school board seats. The candidates for the town seats (one each for Durham, Lee, and Madbury) must reside in that town.

In addition to electing the moderator, 4 school board seats, and the 2021-2022 budget, the ballot also includes collective bargaining agreements with district Bus Drivers, Paraprofessionals, and Support Staff, granting the district the ability to save a larger emergency fund in future years, and a proposal to save up to \$125,000 remaining at the end of the 2020-2021 school year in a Facilities trust fund.
