- II. Treasurer’s report circulated
  - a. Reviewed expenses and income
  - b. Information from IRS submitted but response not yet received
  - c. Treasurer still working with TD Bank to get information for Web sales and donations
- III. Events
  - a. Library has arranged zoom meeting on NH’s History of Agricultural Fair, Steve Taylor, New Hampshire Humanities Council Program for October 7<sup>th</sup> at 7 PM, advertised as co-sponsored by Historical Society. Will link to Library zoom password and advertise on face book, and web.
  - b. Scott arranged for second NH Humanities program, October 28<sup>th</sup> at 7 PM. “Founding Fathers: What were they thinking,” presenter Richard A Hess. Will co-sponsor with library.
  - c. Spring programs will be discussed at future meeting
- IV. Museum
  - a. Received temporary approval for use of Annex for offsite storage

- V. Fundraising

- VI. Bylaws – proposed changes
  - a. Article 1.3 – No changes. Possible discussion at annual meeting.
  - b. Article II.3. The Board of Directors shall consist of the Officers and *a minimum of 3* directors. (suggested change in italics)
  - c. Need to clarify role of directors
  - d. Article II.4 The term of office for all Board members, and Officers is two years. ~~The President and Vice President shall be elected for not more than two successive two-year terms. Two of the four Directors shall be elected each year~~
  - e. Article II.7 The president shall...~~including an auditor~~
  - f. Article II.11 *The officers shall review the Society’s finances at the end of every fiscal year. At that time copies of the Society’s bank statement will be reviewed.* (Change in language referring to auditor)

- ~~g.~~ Article II.13 added *At any point in the year any officer of the Board can request a review of the Society's financial records.*
- ~~a.~~ Article V.2. General Membership meetings shall take place at least 4 times annually. These meetings shall consist of public programs and a brief meeting during which the membership attendees is updated...
