- I. Call to Order 4:40 p.m.
- II. Secretary's Report
 - A. Approval of Agenda

B. Banner/Logo Design

Laura Gund has spoken with Amy Daskal regarding her assistance with both design and logo. Initial thoughts include design of a "Lee The People" town logo and three (3) banner designs specific to each "celebration era", i.e. Indiginous (2024); Colonial (2025) and Revolutionary (2026). The Committee agreed to invite Ms. Daskal to attend the February Committee meeting to discuss details. Laura Gund to coordinate. C. Advertising

The Committee discussed developing a flyer announcing the structure of the Committee's plan for 250th Nation's celebrations (2024 through 2026). Need to finalize logo and banner designs in order to design flyer. Flyer could be introduced at the March 2024 Town of Lee voting event.

The Committee agreed that assistance is needed in the areas of advertising and public relations. Patricia Jenkins and Laura Gund agreed to speak with Bob Cabral to see if he would be interested assisting with advertising/public relations surrounging activities/events.

May be fun to host a similar event which will serve as a "grass roots" event which will foster open conversations to community members to tell stories and look at pictures about historical events in Lee. The Committee agreed to explore potential development of this program.
 - iii. Laura Gund agreed to talk with Dave Miner about carving a "totum" or historically relevant statue carved from a "Mast Tree" for (potential) display at the Lee Town "triangle".
 - iv. The Committee is interested in coordinating with other Town Committees to brainstorm ideas and enlist assistance for development and implementation of events. A list will be compiled of Committees/representatives to invite to a future Nation's 250th Committee meeting.
