Amending a Warrant Article (NH RSA 40:13 IV) Warrant articles can be amended by a simple majority vote

Warrant articles may be amended subject to the following limitations:

- Warrant articles whose wording is prescribed by law shall not be amended.
- Warrant articles as amended shall be placed on the official ballot for a final vote
- No warrant article shall be amended to eliminate the subject matter of the article but the legislative body can make other changes. An amendment can change the dollar amount of an appropriation.

Appropriations (NH RSA 32:6)

- An "Appropriation" is the amount of money authorized to be expended for a specific purpose:
- The amount of an appropriation may be amended; however, the purpose of the appropriation cannot be changed.
- No new purposes can be introduced that were not in the posted warrant or that were not disclosed or discussed at the budget hearing.

Purpose (NH RSA 32:3 V)

"Purpose" means a goal or aim to be accomplished through the expenditure of public funds.

A line on the budget form posted with the warrant or the form submitted to the Department of Revenue Administration or an appropriation contained in a special warrant article, shall be considered a single "purpose."

Raise & Appropriate (NH RSA 32:3)

"To Raise" indicates the source of the revenue

This means funding from any source of revenue, not just general taxation!

"Appropriate" - to authorize the expenditure of a particular sum for a particular purpose. i.e. the authorization to expend municipal funds for a specified purpose.

Warrant Article 1 - Town Officers

To choose all necessary Town Officers for the ensuing year

- Selectperson 3-year position
- Treasurer 3-year position
- Moderator 2-year position
- Supervisor of the Checklist 6-year position
- Trustee of the Trust Funds 3-year position
- Library Trustees (2) 3-year positions
- Cemetery Trustees 3-year position
- Advisory Budget Committee (2) 3-year positions

Warrant Article 2 - Zoning Ordinance

Relative to Article XVII, section II-B;5ii of the 2019 Zoning Regulations (temporary signs), are you in favor of the adoption of Amendment No. 1-2021 as Proposed by the Select Board to remove the following language:

ii. One temporary sign per lot may be located on the owner's property for a period of (30) days prior to an election involving candidates for federal, state or local office or an issue on the ballot.

Majority vote required.

NOTE: Deleted language is struck through

Warrant Article 3 - Operating Budget

Shall the Town of Lee raise and appropriate as an operating budget, not including appropriations by special warrant articles and other appropriations voted separately, the amounts set forth on the budget posted with the warrant or as amended by vote of the first session, for the purposes set forth therein, totaling \$4,882,913. Should this article be defeated, the default budget shall be \$4,574,348 which is the same as last year, with certain adjustments required by previous action of the Select Board or by law; or the governing body may hold one special meeting, in accordance with RSA 40:13, X and XVI, to take up the issue of a revised operating budget only. The Select Board recommends this article. Majority vote required.


FY23 Operating Budget Highlights

- The overall increase from FY 22 is \$308,564 which is a 6.3% change.
- ➤ Government Buildings increased by \$100,052 (New Town Office building rent & expense)
- ➤ Personnel increased by \$105,046; Highway increased by \$93,290 and Fire Rescue increased by \$48,016.
- ➤ Police decreased by \$22,903, Solid Waste decreased by \$25,995 and Parks & Recreation decreased by \$14,500.


FY23 Operating Budget Highlights

- ➤ Highway Department includes funding for an additional full-time employee.
- Fire Department budget includes a wage step scale for personnel.
- ➤ Parks & Recreation budget does not include funding for ORYA programs.
- Heritage and Agricultural Commission budgets were not funded at their request


Operating Budget FY14-23

Warrant Article 4 – Fire Equipment Capital Reserve Fund

To see if the Town will vote to raise and appropriate the sum of One Hundred Seventy Five Thousand dollars (\$175,000) to be deposited into the Fire Equipment Capital Reserve Fund. The Select Board recommends this article. Majority vote required.

As of 12/31/21 this fund has a balance of \$798,011 (a significant portion of this balance encumbered for purchase of a Fire Truck per last year's vote).

Warrant Article 5 – Town Buildings Capital Reserve Fund

To see if the Town will vote to raise and appropriate the sum of One Hundred Thousand dollars (\$100,000) to be deposited into the Town Buildings Capital Reserve Fund. The Select Board recommends this article. Majority vote required.

As of 12/31/21 this fund has a balance of \$387,100.

Warrant Article 6 - Transfer Station Equipment Capital Reserve Fund

To see if the Town will vote to raise and appropriate the sum of Seventy Eight Thousand dollars (\$78,000) to be deposited into the Transfer Station Equipment Capital Reserve Fund. The Select Board recommends this article. Majority vote required.

As of 12/31/21 this fund has a balance of \$185,414.

Warrant Article 7 - Highway Dept. Road & Bridge Capital Reserve Fund

To see if the Town will vote to raise and appropriate the sum of Ninety Thousand dollars (\$90,000) to be deposited into the Highway Dept. Road and Bridge Improvement Plan Capital Reserve Fund. The Select Board recommends this article. Majority vote required.

As of 12/31/21 this fund has a balance of \$619,932.

Warrant Article 8 – Hwy. Equipment Capital Reserve Fund

To see if the Town will vote to raise and appropriate the sum of Fifty Five Thousand dollars (\$55,000) to be deposited into the Highway Equipment Capital Reserve Fund. The Select Board recommends this article. Majority vote required.

As of 12/31/21 this fund has a balance of \$357,883.

Warrant Article 9 – Lee Library Building Capital Reserve Fund

To see if the Town will vote to raise and appropriate the sum not to exceed Thirty Thousand dollars (\$30,000) to be deposited into the Lee Library Building Capital Reserve Fund. The Select Board recommends this article. Majority vote required.

As of 12/31/21 this fund has a balance of \$376,446.

Warrant Article 10 - Fire Ponds & Cisterns Capital Reserve Fund

To see if the Town will vote to raise and appropriate the sum of Twenty Thousand dollars (\$20,000) to be deposited into the Fire Ponds and Cisterns Capital Reserve Fund. The Select Board recommends this article. Majority vote required.

As of 12/31/21 this fund has a balance of \$174,802.

Warrant Article 11 – Contingency

To see if the Town will vote to establish a contingency fund for Fiscal Year 2023 for unanticipated expenses that may arise and further to raise and appropriate Twenty Thousand dollars (\$20,000) to go into the fund. This sum to come from the Unassigned Fund Balance and no amount to be raised from general taxation. Any appropriation left in the fund at the end of the year will lapse to the general fund. The governing body shall annually publish a detailed report of all expenditures from the fund. The Select Board recommends this article. Majority vote required.

Warrant Article 12 – Fire Pond & Cistern Change of Purpose

To see if the Town will vote to change the purpose of the existing Fire Pond and Cistern Capital Reserve Fund to allow for the installation of new fire ponds and cisterns and to allow for repair and replacement of existing fire ponds and cisterns and to name the Select Board as agents to expend. The Select Board recommends this article. 2/3 vote required.

Warrant Article 13 – Elderly Exemption

Shall the town modify the provisions of RSA 72:39-a for elderly exemption from property tax in the Town of Lee, based on assessed value, for qualified taxpayers, to be as follows: for a person 65 years of age up to 74 years, \$217,500; for a person 75 years of age up to 79 years, \$262,500; for a person 80 years of age or older, \$337,500. To qualify, the person must have been a New Hampshire resident for at least 3 consecutive years, own the real estate individually or jointly, or if the real estate is owned by such person's spouse, they must have been married to each other for at least 5 consecutive years. In addition, the taxpayer must have a net income of not more than \$46,500 or, if married, a combined net income of less than \$59,400 and own net assets not in excess of \$222,500 excluding the value of the person's residence. The Select Board recommends this article. Majority vote required.

Warrant Article 14 – CIP Appointment Authority

To see if the Town will vote to authorize the Select Board, as provided by RSA 674:5, 1) to remove the Planning Board's responsibility for the town capital improvement program and 2) to establish, appoint and implement a Capital Improvement Program Committee whose purpose shall be to prepare and amend a recommended program of municipal capital improvement expenditures projected over a period of at least 6 years to assist the Select Board and the Advisory Budget Committee in completion of the annual budget. Membership of such committee shall include at least one member of the Planning Board and may include but not be limited to other members of the Planning Board, the Advisory Budget Committee, the Select Board, town employees, and residents of the Town of Lee. The Select Board recommends this article. Majority vote required.
