## **A. Waste Reduction/Composting:**

Dean: Toby says the composting money in the transfer station budget is for buying (and then offering to the public) outdoor compost bins.

The Solid Waste Committee approved a pilot program to explore composting at the transfer station via Mr. Fox.

Toby reported on changes to the market. Mostly moving against us, costing more or getting less when disposing of various waste, but recycling remains very viable in Lee, mostly due to the efforts of the citizenry and transfer station staff to produce "clean" waste, meaning well sorted with fewer than 10% contaminating items.

Chuck: Had a relevant book Community Scale Composting. Re: Matt: Draft Guide on Building a Container at Home – N/A Dean needs to reup asap.
