IV. A. Chuck: Backyard Farming Initiative update. Almost twenty people attended the April 29 BFI hosted by Don Quigley, speakers Dick Wolmar and Yuda and Amy Daskal. Went well, thanks everyone. May 23 Kristen Cisneros and Chuck himself will present on canning, fermenting, cool storage live & dead, and continuous harvesting, including a show and tell. At the Lee Grange.

IV. B. The committee discussed Professor Mike Mooiman's presentation cohosted with the energy committee April 30. All agreed it was a stimulating talk. Takeaways: (1) In NH around 2/3 of energy is wasted and only one third put to

work, indicating energy efficiency efforts may the most cost-effective way to "find" new energy, rather than new sources. (2) New England is not approving new energy projects at a rate to avoid future winter rolling blackouts!

IV. C. Jen Messeder absent. Dean, Paul & Chuck attended the Low Carbon Diet intro session before the Mooiman talk. It went well, with the professor referring warmly to Jen's intro several times during his talk. We're worried about sufficient attendees for first session Monday May 14 7pm Safety Complex.
