APPLICATION FOR HARDSHIP TAX ABATEMENT (and APPEAL PROCEDURES)

- 1. This application must be made in writing to the local assessing officials (Select Board) no later than March 1 following the property tax bill.
- 2. If a taxpayer is not satisfied with the decisions of the Select Board, or if he/she does not receive a decision within a reasonable period of time (not more than 60 days,) he/she may appeal in writing no later than September 1 to the Board of Tax and Land Appeals, Johnson Hall | 107 Pleasant Street | Concord, NH 03301-3834 www.nh.gov/btla
- 3. In lieu of appealing to the Board of Tax and Land Appeals, the taxpayer may, no later than September 1, appeal by petition to the Strafford County Superior Court. An Appeal may be made either to the Board of Tax and Land Appeals or to Superior Court, but not both; and the decision of either judicial body is final except in cases of law which may be appealed by the New Hampshire Supreme Court in accordance with the Provisions of RSA 541.
